Terms and Conditions

- I. **Payment:** Payment in full is required upon completion of moving services, unless otherwise approved. Any additional fees incurred during the move must be settled with the movers before the completion of services.
- II. **Packing Responsibility:** The customer is responsible for ensuring all boxable items are appropriately packed and ready for the scheduled move date and time. Movers will not be liable for any damage to improperly packed items.
- III. **Appliance Handling:** The customer is responsible for disconnecting and reconnecting any appliances before and after the move. Movers will not handle appliance disconnection or reconnection. Refrigerators **MUST** be emptied before transport.
- IV. **Belongings Care:** Movers will exercise reasonable care in handling customer belongings but are not liable for damage due to normal wear and tear, inherent vice, or fragility of items.
- V. **Customer Presence:** The customer must be present during the loading and unloading of all belongings, unless otherwise confirmed beforehand. Movers will not unload items without the customer's presence to verify the condition and location of items.
- VI. **Force Majeure:** Movers are not responsible for any loss or damage resulting from circumstances beyond their reasonable control, including but not limited to fire, flood, acts of nature.
- VII. **Scheduled Move Window:** The customer agrees to a 1-hour window for the scheduled move date and time. If the movers arrive within that window, the move will proceed as scheduled.
- VIII. **Claims Process:** Any claims for loss or damage must be submitted in writing within 3 days of the delivery of possessions. Claims made after this period will not be the responsibility of the movers.
- IX. **Safety and Conditions:** The customer agrees to provide a safe, hazard-free environment for the movers to perform services. Movers reserve the right to refuse service in unsafe conditions. This includes refraining from smoking of any kind, indoors, while movers are working.
- X. **Access Requirement:** The customer agrees to provide access to all areas where belongings requiring moving services are located, and to not block access to any stairs exits in case of emergency.
- XI. **Routing and Transportation:** The customer's property will be moved via the most direct route and method of transportation as determined by the movers.
- XII. **Grace Period:** The customer agrees to allow for a 15-minute grace period after the scheduled move time before additional fees may be applied.
- XIII. **Subcontracting:** The customer agrees that the movers may subcontract any portion of the move to third-party carriers or helpers at their discretion.
- XIV. **High-Value Items:** The customer agrees to provide a list of high-value or fragile items at least 72 hours before the scheduled move to ensure proper handling. Items over 300 pounds must be listed with approximate weight and dimensions.
- XV. **Safety Measures for Children and Pets:** The customer agrees that children unable to take vocal commands must be properly restrained during the move. All pets must be properly restrained, and kenneled if necessary. The movers are not liable for any injuries caused by improper restraint and not responsible for the loss or injury of improperly restrained pets.
- XVI. **Perishable Items:** The customer agrees to remove all perishable food items before the scheduled move date. Movers will not be responsible for any spoiled perishable items.
- XVII. **Plant Handling:** Movers will take reasonable precautions with customer's plants but will not be responsible for any damage or death of plants during the move.
- XVIII. **Health Hazard Items:** The customer agrees that movers may refuse to handle, or in extreme cases to destroy, any items deemed to be a health hazard.
